THE MYTHS AND REALITIES OF THE LINK BETWEEN ORAL DISEASE & SYSTEMIC CONDITIONS

COURSE OUTLINE

This presentation will explore and explain in detail the interrelationships between systemic diseases and oral health. The link will be made between periodontal disease from the etiology and pathogenesis of the disease to the role of the host response and their impact on systemic health. Risk assessment will be covered in the context of the oral/systemic connection. The participant will become familiar with various systemic disorders and understand which conditions do and which don't interact with periodontal diseases. Learning how to discuss this new paradigm in everyday dental practice with patients will also be discussed.
