In His Words

A Student's Perspective on Dental School Life During a Pandemic by: Dr. Charles Buchanan, 4th Year Dental Student UNLV School of Dental Medicine

Being a dental student means long hours of studying, sacrificing personal time, being met with challenges daily, and the occasional impostor system. However, I've also had some of the best times of my life in dental school as well.

Focused on the finish line

I first fell in love with dentistry when my older sister got her braces removed around the age of 15 years old. When she got them removed, she had a noticeable boost of self-

esteem. She began to smile more and enjoyed taking more pictures. I thought WOW! dentistry can really change someone's entire perspective of themselves. From there, I was sold. I looked into the profession and everything I found mentioned the stability of the career, great income, and a great work life balance. What's kept me passionate about dentistry – and has pushed me through my 4th year of dental school - is being able to give to people exactly what my sister received. Practicing dentistry affords me the opportunity to change lives and that's where I receive the most joy. 2020 has been full of challenges, but it was important to me to not lose my focus. Managing graduation requirements during the pandemic hasn't been ideal but I've found as long as I stay optimistic about my future I'm able to tackle my days well.

Service to Organized Dentistry Aside from treating patients, I'm heavily involved with organized dentistry. I first got involved with grassroots initiatives as a second year during the most recent legislative session in Nevada. A bill, SB366, was introduced which outlined the introduction of dental therapists in the state of Nevada. Through the American Student Dental Association (ASDA), I was able to use my voice as a student and join in the fight against midlevel providers. Although SB366 passed, I discovered a passion for advocacy and saw firsthand the power of united dental voices. I now serve on ASDA's national Licensure Task Force. We are currently developing a state-by-state strategy to advance licensure reform efforts in states that have not yet made changes due to the COVID-19 pandemic. I believe advocacy has been one of the most important pieces of the dental school experience.



My fourth year in dental school has been a rollercoaster ride. I was elected as ASDA District 10 Trustee on March 7th, 2020 and about a week later the national shutdowns began. I've had this experience as Trustee completely virtually and I'm leading a team of about 90% people I've never met in person. As Trustee I'm responsible for providing resources to 7 local chapter presidents, and communicating national news, events, strategies. In the board room, I help make decisions on strategic goals, finances, initiatives, appointing members to positions - it's really cool. It's taught me so much about my own resiliency and ability to pivot, I've improved in my



communication, I've learned how to set boundaries, how to be decisive and defend my stance, and to ask for help when I need it. I would do it all over again.

What I've Learned

What has been most important to me during this time are my boundaries. It's been really important for me to know what my values are and what my hard limits are. I can't get

to everything I need to get to in one day and that's okay, I leave it for tomorrow. Sometimes for me that looks like taking Saturday to not respond to any emails or it's asking for help - delegating a work task to someone else who could also perform that task. I make time for my loved ones. It's easier now in my last year of dental school now that I'm not doing as much studying as I once had to - but even during my first two years of dental school I made it a priority to keep parts of my identity that weren't dental related. It's one of the biggest pieces of advice I give to incoming students. I suggest to incoming students to pick at least one hobby that you had before dental school that makes you come alive or relaxes you, reminds you of home, whatever it is and commit to doing that at least once a week. During my first year of dental school, I would reserve Thursday nights for wax and relax. I would practice my wax ups with a glass of wine, and watch my favorite tv shows. It was a great way for me to be productive while also engaging in activities that I enjoyed.

Eye on the Prize

Moving forward, I am excited to see what the rest of my fourth year in dental school looks like. I've managed to complete most of my graduation requirements during the first semester which was a goal of mine. I can relax now for the most part and I look forward to finding the perfect office to begin my career as a dentist.

Did You Miss Information About Administering the COVID-19 Vaccine?

As of January 14, 2021, Nevada Gov. Steve Sisolak, Nevada Health Response, Nevada Department of Health and Human Services issued the following <u>press release</u> Nevada Health Response Guidance: <u>Directive 011 Administration of Vaccines by Providers of Medical Services</u>

In summary...

What it says: All qualified healthcare providers are encouraged to administer COVID-19 vaccinations.

Who: Dentists are qualified to administer the vaccine. Hygienists are qualified to administer the vaccine, but must be supervised.

Word of Caution: Although the directive allows dentists to administer the COVID-19 vaccine outside of a Point of Distribution (POD), dentists are cautioned against administering the vaccine in one's office.

What to Do to Administer the Vaccine: Complete the CDC's self-paced vaccine administration course.

- <u>Review modules prior to taking the course</u>. or
- Take the course and view the modules within the e-course.
- Complete the course.
- Go to <u>https://tceols.cdc.gov</u> and set up an account.
- Under "search courses," search for the course: "WB2502 Immunization: You Call the Shots-Module Eighteen- Vaccine Administration" and add the course to your list.
- To earn CE for courses:
 - Under Pending CE, click on the Course Evaluation and complete it.
 - Click on the Post-test and complete it. If you don't pass the Post-test, you will have one opportunity to retake it.

Register through SERV-NV to help.
