

### **COVID-19 Vaccine**

# Information provided by Dr. Antonina Capurro, Nevada Dental Health Director regarding the COVID-19 vaccine:

Here is what we know so far:





- 2. Dentists, dental hygienists, and their team in rural Nevada will be eligible for a vaccine in their Tier if the county has enough for everyone. Although there are groups, the population is smaller and it is easier to get through the groups faster.
- 3. Reno, Carson, Vegas area dental practitioners should expect the vaccine mid to late January. NSHE will have their own POD, Carson likely will have PODs, and Reno and Vegas will have mass vaccination clinics i.e. at the convention center.

For those that submitted their information to the <u>DHHS survey</u>, an email confirmation was sent out. We will do this every week until the 8th of January. We will send an email out the first week of January with notification that **the survey will close on the 8th.** 

## **E- Prescriptions Update From the Nevada Board of Pharmacy**

Effective January 1, 2021, Nevada law mandates that all controlled substance prescriptions MUST be given to a pharmacy by electronic prescribing ("e-prescribing"). There are certain exceptions to the e-prescribing mandate, and the Board of Pharmacy may exempt a practitioner from the e-prescribing mandate for 1 year, until December 31, 2021, based upon "economic hardship, technological limitations beyond the control of the practitioner or other exceptional circumstances." NRS 639.23535(1) and (2).

In order to claim an exemption, practitioners must complete an exemption form provided by the Board and maintain a record of it. The exemption form is **HERE**.
