## GUIDELINES FOR NOMINATION

**Nomination Deadline: June 15, 2018**

### Award Profile

- Nominee must be current or past council, committee or task force member.
- Has made contributions that have advanced the work of the AGD in a measurable and tangible way.
- Has demonstrated exemplary dedication to the organization.
- Has been an innovator and leader in making positive changes for the benefit of the membership and dental profession.

### Guidelines and Selection Process

- Nominations **may only** be submitted by an AGD officer, trustee, regional director, or council, committee or task force member.
- May not hold a current position on the AGD Board or Regional Directors.
- The award will not be given to the same individual more than once; therefore, past recipients are ineligible.
- A nominator is limited to one Distinguished Service Award nomination per year.
- A completed nomination form, letter of recommendation, along with a copy of the nominee's curriculum vitae (CV), must be received at AGD Headquarters by June 15, 2018.
- Other supporting documentation to substantiate the character of the nominee may also be submitted (testimonials, photos, newsletters, articles).
- It shall be the duty of the Awards Committee to act as the Screening Committee for all nominees.
- Staff will forward all nominations and supplemental materials to Awards Committee for consideration.
- Each committee member will independently evaluate and select the individual nominee most deserving of the award.
- Typically, only one award is granted annually. However, if the caliber of nominees is particularly outstanding, two awards may be granted.
- If a nominee does not meet the aforementioned criteria, the Awards Committee has the option to forgo recommending that recipient to the AGD Board.
- The Awards Committee will present its final selection(s) to the AGD Board for final review and approval.

### Award Presentation

The recipient will be presented with the AGD Distinguished Service Award at the 2018 Annual Meeting in Chicago.
